So, to all Capable, Specialized Companies only, which have previous experience in the Oil and gas sector, which have the intention to submit to this tender, Offers of non-specialized companies in the required field will be excluded.

Brief of Scope of Work:- Whereas the Arabian Gulf Oil Company (AGOCO) desires to procure services for the design, engineering, manufacturing, assembly, supply, installation, civil works, inspection, complete testing & commissioning and delivery of completely assembled unit of a new step down transformer 250KVA, 3.3KV/415V, 2x2.5%, 50HZ with power cables, switchboard and all other services required to execute the project on a Turnkey basis in accordance with the relevant international Code and Standard and AGOCOs Technical requirements

The Tender Booklets handing will be during the period from 01/01/2018 to 02/01/2018 between 09:00 AM to 13:00. The handing will be to their representatives.

The Tender booklets are to be obtained from office No 343 , AGOCO Main Building – Elkish, Benghazi , against payment as mentioned in the above table, paid through non-refundable certified cheque (From a Libyan bank) Credited to Arabian Gulf Oil Company (AGOCO) .

Advanced companies must submit the documents required under this Declaration, under the following conditions:

1. Representatives have to be authorized through official letters from their Companies.
2. Who desire to bid has to present his qualification and past-experience, supported with documents related. Also legal and financial documents, according to the prevailing laws for those registered in Libya, have to be submitted (all in separate envelope). These are :

- a. Decree of formation.
- b. Valid Commercial registration.
- c. Valid registration Certificate from Chamber of Commerce.
- d. Valid certificate of working permission.
- e. Valid proof of tax payment.
- f. Minister of economy working permission.

Bid to be submitted in five (5) separate, red wax sealed envelopes stamped from bidder, indicating project name and participating bidder name to be indicated on each envelope :

- **First envelope** contains company supporting legal documents , a mentioned in condition .
- **Second envelope** is for technical offer (one original + one copy) without price; otherwise, it will be rejected. Offer Validity should be at least three (3) months from the Closing Date.
- **Third envelope** is Un-priced commercial offer (one original + one copy) (without price; otherwise, it will be rejected) has to contain the required payment conditions with the necessity to agree on all AGOCO general terms and conditions to participate in the tender, and it should contain a copy of commercial offer without price.**Fourth envelope** is Priced commercial offer (one original + one copy).
- **Fifth envelope** the Contractor shall be at his own expense obtain and maintain for the Company a bid bond in an amount equals (%0.5) of the total value Such Bond shall be established as a certified cheque or an

irrevocable, unconditional and confirmed Letter of Guarantee through a First Class Libyan bank or through a First Class European Bank confirmed and advised to the Company through the Libyan Foreign Bank (LFB) – Tripoli, or through the British Arab Commercial Bank (BACB) – London and to be delivered with offers and the text of this guarantee must be the acceptable to the company and is rewind to those who do not anchor the tender, And shall be valid for six (6) months from the date of submission of the offer, and the letters or instruments shall be returned to the initial bidder.

3. Bids have to be submitted during the official working hours, to Sub-Tender Committee, Head-office, Arabian Gulf Oil Company, El-kish- Benghazi - Office 343 before the closing date on Thursday 01/02/2018 13:00 o'clock.
4. Any bid which does not comply with the above mentioned conditions will be rejected. Low price is not the only controlling factor in evaluation.
5. AGOCO reserves the right to cancel the tender without obligation to give any reason for such cancellation and it has the right to handle the data in the proper manner to it after finalizing the tender.
